3. Energy consumption measurement and Waste management:

Klassis Compliance: ABC Company has established an accurate baseline for usage in a 12-month period in order to address seasonal trending. The baseline period is defined as January 2014 to December 2014. Results against goals (requirement #4 below) are as follows:

- B.) Calculate Scope 1 greenhouse gas emmisions: "NOT APPLICABLE"
- C.) Calculate Scope 2 greenhouse gas emissions:
 - i. Electric Usage:

The calculation is given below according to the emission factor announced by Turkish Electric Agency. $(0.64 \text{ kg CO}_2/\text{kWh} - 2013/0.62 \text{ kg CO}_2/\text{kWh} - 2014)$

- 1. Year 2013: 1730 kWh consumed x $0.64 \text{ kg CO}_2 = 1.107,20 \text{ kg CO}_2$
- 2. Year 2014: 1671 kWh consumed x $0.62 \text{ kg CO}_2 = 1.036,02 \text{ kg CO}_2$

Klassis Compliance: Working off the baseline established in requirement #3a,b, Klassis has set at least one goal in each category. The goal measuring period is 12 months. Goals are determined in conjunction with Klassis senior management, and follow the format below as an example only:

- A.) Energy Consumption:
 - i. <u>Electric Usage:</u> Reduce company office energy use 4% by year end 2016 defined as in Sustainability Policy
- B.) Calculate Scope 2 greenhouse gas emissions:
 - i. <u>Electric Usage:</u> Reduce scope 2 GHG emissions 9% by year end 2016

5. Public Disclosure:

Klassis Compliance: Klassis has a committee that meets on annual basis. This committee reviews the progress of reduction initiatives against the EMS goals and ensures that Klassis is compliant with our ethical code.
