 - Manufacturing facilities powered in part by alternative energy sources
 - Formal environmental-packaging policy
- **Objectives 2:** We will track and create a baseline for all purchases made with recycled content, which are recyclable, biodegradable and compostable.
- **Objectives 3:** We will track and create a baseline for all purchases of products or materials that are considered non-toxic or reduced toxic.

Reporting

- We will report our progress against our goals once per year. Objectives will be controlled via sampling method in periods
- Bussiness operating procedures and practices will be reviewed at least once per year
